OVC Faculty and SRCAC staff presents a Training of Trainers (TOT) to train professionals from Child Abuse Organizations Building Resiliency in Child on the OVC curriculum, Building Resiliency in Child Abuse Organizations.

The intent of TOT is to provide knowledge and skills necessary to deliver the training to other managers and supervisors. TOT is open to CAC staff, CASA, members of state chapters and all who work with organizations/agencies that provide services to children and families that are victims of child abuse.

## Evaluating the Executive Director; Your Role As a Board Member

Coordinator

Every board of directors has a responsibility to conduct an annual evaluation of the Executive Director of their organization to ensure they are performing their job duties in a manner which reflects the overall goals and objectives set forth by the board. However, many boards often neglect their duty in this regard. They may fear conflict or feel uneasy about the idea, especially if a process is not already in place.

Despite everyone's discomfort with the thought of an annual performance appraisal, according to Board Source there are many benefits both for the Board as well as the Executive Director.

#### Executive Director Benefits:

- The process requires a clear job description for the chief executive. This document clarifies the boundaries for his or her responsibilities.
- Annual expectations must be spelled out. These guidelines help the chief executive focus on the important issues during the coming year.
- This is the one official opportunity for the chief executive to bring major concerns, budding disagreements, or future issues to the board's attention.

#### Board of Directors Benefits:

- The board has a structured opportunity to communicate with its one-and-only agent. This is the time to discuss any big issues concerning the organization.
- If the board is satisfied with the chief executive's performance, it has a tangible opportunity to express that satisfaction by approving a salary increase.

Regardless of the evaluation process/tools to be used, The National Center for Non Profit suggests three broad goals to keep in mind:

- 1. To clarify expectations between the board of directors and the executive director.
- 2. To provide insight into the board's perception of the executive directors' strengths, limitations, and overall performance.
- 3. To foster the growth and development of both the executive director and the organization.

Areas to be assessed should include the following:

- \* staff relations;
- \* administration;
- \* planning;
- \* leadership;
- \* fiscal management;
- \* external public relations;
- \* effectiveness in working with the board of directors to achieve the annual plan; and success helping the board achieve its own accountability and level of responsibility.

While the annual evaluation is essential, it is important to remember that executive directors need feedback all year round. Like any employee, executive directors need praise and acknowledgment for work well done, and immediate feedback when problems arise. In the best situations, the board president and officers have established good working relationships with the executive director where constant feedback flows in both directions. The annual formal evaluation is an important component of, not a substitute for, that relationship.
