Child abuse professionals affiliate with a CAC who register for the trainings listed above are eligible to apply.

When do I need to submit my application?

Travel Assistance application should be submitted as soon as possible for review.

If I am awarded travel assistance, what limitations apply to my travel reimbursements?

Participants are required to adhere to Federal Per Diem Mileage, and Lodging guidelines. Receipts for lodging (with hotel daily rate) must be submitted. <u>SRCAC cannot reimburse partial payment</u> <u>exceeding the per diem.</u> SRCAC will reimburse traveler for their airline or mileage (**up to \$300**). If traveling by airplane, **ticket purchase receipt with boarding passes** must be provided to be reimbursed. <u>SRCAC cannot not reimburse for airline travel without boarding passes</u>. If traveling by car, you must submit proof of mileage (i.e. Mapquest). Additional details on the reimbursement process will be provided upon scholarship award.
