Also, provided one on one technical assistance to 4715 child abuse professionals through face to face contact, telephone or e-mail.

OJJDP-TRAINING GRANT - In 2019, through the OJJDP Grant, the Training Department provided in-person training and live, online trainings to 2,208 people from 47 states, DC, & Canada; provided 210 scholarships to attend the 35th International Symposium on Child Abuse to people from 38 states and Puerto Rico; and provided archived online trainings to 16,353 people from all 50 states, DC, U.S. Virgin Islands, Guam, Puerto Rico, Northern Mariana Islands, U.S. Minor Outlying Islands, and 27 foreign countries. The Child Abuse Library Online had 33,523 unique visits and a total of 47,696 visits from people in all 50 states, DC, and 181 countries.

The 35th International Symposium on Child Abuse (Symposium), took place at the Von Braun Center, in Huntsville, AL, from March 18-21, 2019. This successful, informative, and innovative multidisciplinary conference featured more than 170 workshops, over 140 presenters, and trained 1,586 professionals from 49 states, DC, 2 territories, and 7 countries. The Symposium has hosted and trained professionals in the field of child abuse, maltreatment, and prevention for over 35 years and continues to be one of the leading child abuse conferences worldwide.
